4 Matters Arising

- Response from Malcolm White This was in relation to the proposed 8
 houses applied for by the golf club, and the suspected change of 'type of
 house' due to online advertisement. Malcom White explained that there
 has been no application for a change in the planning application, and until
 there is there is nothing which can be done.
- Report from Community Council Forum John Foulkes raised the issue of why Westhill does not have a fire station? The answer to this was that our area is covered by North Anderson Drive, which is a 24/7 station. The other stations in the area, such as Insch & Inverurie are RDS stations (Retained Duty System), manned by individuals who have other jobs etc. Another issue raised was that of the lack of Police presence at Community Council meetings, not only by ourselves but other Community Councils too. Along with this, the detail of the reports were not always at the same standard which they used to be. Overall, the Garioch Community Council Forum was a very worthwhile evening, and it is very helpful to hear from other community councils.
- Cllr McKail noted that there were discussions regarding having a Community Safety Hub, which would mean having Police and other services running out of the Westhill Police Station. This is encouraging to retain the use of the building.

5 Police Report

The report was circulated prior to the meeting. No comments were raised. Attached as PDF.

6 Kingsford Stadium Development

This item was taken first in the meeting. Audrey welcomed those interested in this issue, explaining that at this point in time WECC have not made an opinion on the matter. We have not seen any further information than what was published in the press.

A number of items of concern were expressed by those present at the meeting. This included traffic, parking, safety in the area, policing, people drinking in Westhill, light and noise pollution, the use of the stadium for concerts or rugby etc, proximity to the pipeline and loss of views & amenity.

A number of residents who live in close proximity to the proposed site were present, and expressed their disapproval due to the affect it will have on their standard of living. The land is not currently zoned for any development in any Local Development Plan.

Audrey commented that speaking to Kingswells CC and also the Kingswells councillors will have greater impact, as they are the ones who will have a greater say in the consultation.

It was noted that a proposal for a driving range was previously knocked back due to light pollution, setting a precedent for other developments, and being on greenbelt – in 2005ish. This shows that other developments have been objected to on similar principals.

Audrey reminded everyone of the fact that there is no planning application as of yet, so we don't know a lot of information yet.

It was expressed that AFC are the applicants, and everybody should contact them with their concerns, as they are the ones with the power to change anything. It was questioned who owned the land – a farmer who has agreed a missive with AFC.

It was questioned whether AFC had been in touch with Aberdeenshire Council on this issue. Cllr Walker confirmed that the head of planning is aware of the plans, and will ensure someone is working close with the City Council planning development.

Why do they need this site, when they have planning permission at Loirston?



	It was asked what would happen if the application was refused by Aberdeen City Council? It would go to the Scottish Reporter in Edinburgh. Cllr McKail expressed the fact that all our local councillors have to remain neutral at this point in this process, as they would have to declare an interest and not be included in any consultation. It was noted that it is believed that the head of the City Council has not ruled herself out with her comments, as she was not commenting on a live application at the time. It was questioned whether we would use our website and social media to advertise any dates/important information etc. We will.	
	It is important to express all opinions within the community, as there will be many	
	who are in favour of the plans also. One gentleman noted the possibility of Westhill being targeted to be included within the City boundary if the Stadium is the edge of our boundary. It was questioned whether there had been communication with the Lawsondale	
7	Trust. Nobody was aware of anything. Planning Watch	
	Strawberryfield Road – APP/2016/1352 & APP/2016/1442 Modification of Planning Obligation (Affordable Housing Provision) of Planning Permission Ref: APP/2010/0289 (Erection of 10 Houses and Associated Infrastructure) & Erection of Dwellinghouse Previously, an application was approved for ten houses on this site at Strawberryfield Road. This included three affordable houses, following the previous rules of 30% affordability. Since the application, the rules have changed to up to 25%. This means they have changed their application to now contain two affordable houses rather than three. We have now missed the deadline for comment on this application, however the land is allocated for development anyway. This further application seems to simply be an addition to the development, with one singular house.	
8	Westhill in Bloom Cllr Walker is hoping to hold a meeting with everybody interested in running this competition soon. We will need to get more publicity going, in order to receive nomination forms.	Cllr Walker
9	Update on Gateway Art Feature We are still awaiting the written confirmation of the use of the land for the Art Feature from Doug Milne. It has been expressed verbally but not on paper. The last meeting was held with Sheila Waterhouse, which was extremely beneficial to the group. She explained how other groups have done it, including the use of recycled materials, and also lighting the feature. It is our hope to erect a 6 foot white question mark in the location, advertising the fact that we are hoping to construct an Art Feature. Obviously this is still in the early stage, however we want to raise as much interest as possible, along with raising as much money as we can for the project. A rough figure of £50,000 has been suggested. David Ewen questioned if we would get a specific breakdown of the costs, in case we can save money in any areas. We will consult as many individuals and groups as possible, to ensure ideas are shared and encouraged, along with utilising the website, Facebook & Bulletin.

Roads officers will now attend our Ward meetings and hopefully this will progress some issues quicker.

Hillside Road steps

No update since last meeting. Funding agreed in principle by ISC but needs to go back to Area Committee for comment.

In addition at the meeting

There were reports that there may be raw sewage in the pond in Arnhall Moss. It has been confirmed that this is not the case, however there is a lot of litter which needs to be cleared. Environmental Health will keep an eye on this.

12 Website Report/Communications Group

An arrangement has been put in place to potentially secure more media coverage for WECC activities. When a link to major web stories is posted on Facebook, it will also be sent to the local press (*Press & Journal* and *Evening Express*). Web traffic continues to grow. The biggest single number of views was 834 on May 17 this year, which would have been on the back of news about the Dons' stadium proposal. We have posted a note on the website – partly in response to emails from residents asking us to oppose the stadium – that WECC has no view at this stage on the proposal; will scrutinize plans only when they are formally submitted; the land lies with the city council boundary. – *David Ewen*

In addition at the meeting: It was noted that the Council had not tidied up around the Rotary Stone, however this has now been done by volunteers. There were excess plants available, of which John Imrie asked for suggestions of where could use them. Iris suggested the Old Schoolhouse, so it is believed some have gone there. They will be watered weekly this year by Perfectshine, compared to fortnightly in previous year. Perfectshine will continue to get free advertising in Bulletin in return for the watering and have confirmed they will not be charging us for the extra watering's. Thanks were expressed to both John and those in Rotary for all their hard work in organising these baskets.

Art Project: We held a very successful Scarecrow Trail on Sunday 29th May, as part of Gala week events. There were only 29 creations this year. However they were admired and voted on by at least 120 to 150 people during the course of the day. Two prizes were awarded – one for the favourite Scarecrow and one for the best returned form. The children received a certificate and a £10 voucher for Art & Craft goods from Waste Enterprise, this expense approved by the treasurer. The WAP had claimed no other expenses for this event. His problem is that he finds it difficult to communicate with the construction agents in order to get anything done. It has also been confirmed that Marc Mills would be happy for W&ECC to purchase a plaque to explain who the artist is behind the boar sculpture at the shopping centre.
