4 Janette Taylor (AC Environmental Health) - Seagulls in Westhill/Elrick

Janette gave an interesting presentation on gulls in the Westhill area. The slidepack can be viewed at this link living-with-gulls.pptx

Re the trial at Westhill Primary using a solar powered sonic device, this is being trialled elsewhere to confirm if it is helping to reduce gull numbers. Projects are being considered for secondary schools. Audrey suggested that WECC could help with that, like reminding the Academy to reduce amount of food litter.

1. Larg/Broadstraik Park (Malcolm) -

A young local resident has been doing a lot of good work to keep the park looking tidy, like cutting & raking grass.

Malcolm attended a meeting recently run by Nescan on the role of communities in Just Transition. He will get the minutes of this for us.

2. Litter Picking (Gordon)

Having issues in finding out from Norman Wright the status of the 4 additional bins he had promised in June we could get. Ron Mckail will help to get this resolved.

6 Police Report

Public Nuisance incidents are 6 for September, August was only 1.

Concerned that there has been a serious injury assault.

Cllr Mckail mentioned the issue of incidents potentially being caused by youths coming to Westhill using their free bus passes. The police report isn't detailed enough to show that the bus passes are a contributing factor.

There was discussion on the recent incident of a female defecating at the back of Duncanos. Maya had put a link to the P&J article into our Whats App, which some members felt was inappropriate. Other members appreciated the heads up on a potentially reputationally damaging story.

8 Rotary Update/Exchange- Roy Mitchell

Men Shed are going to make a base for the pool table. Hope to be able to put it in Westdyke Leisure Centre.

The Petanque court is open for bookings. David Dent has created a Whats App group for it.

Senior Citizens party on 1st December is being organised.

Rotary stone near Tesco roundabout has been cleaned up, but the light isn't working. The Council will sort it at some point.

Lazy Sunday Afternoon 2025 will be on 8th June.

9 Asylum Seeker Hotel

Numbers are fairly stable at around 300, as that is near the maximum. Pressure on the clothes bank run by the churches. The Swimming Pool is now available but some guys don't have towels or trunks.

The community minibus has been booked by the resettlement team to take service users on day trips to Peterhead, Fraserburgh & Banff in early December, as these are the towns that they are more likely to be offered housing at if they wish to settle in this area.

Funding for the healthcare provision at the hotel is coming from the Home Office funding to the Council.

Ward 13 Councillors updates

Cllr Ron Mckail

A lot of Council time is being taken up with the Council budget and how to reduce the deficit.

All the affected Area Committees objected to the Hill of Fare turbines so there will be a Public Inquiry.

Staff at Westhill Primary have difficulties with parking as the car park at the school is a public one, there is no designated staff parking area.

The Garlogie Beam Engine has had open days & schools have visited

Cllr Fatima Joji

There was an information session last week in Ashdale Hall by Aberdeenshire Sight Loss, Hearing Loss & Deafness organisations. A resident attending it had advised that Fatima an issue they are having is with the buses. They would like to see signage in the buses to show where the stops are, Fatima has contacted Stagecoach about this.

Cllr Iris Walker

Some lighting columns in Westhill have been removed as they are unsafe and there is no budget to replace them. Iris attended the Health & Social Care Partnership road show at Trinity Church yesterday. Had conversation about hospital transport. Iris requested that David Ritchie talked at next meeting about the hospital transport service he provides.

There has been fires lit at Carnie Woods by asylum seekers. The Fire service & Police have run awareness sessions at the hotel on the risks around fires in the woods.

Carnie Woods – Total Energies volunteer group removed around 40m unsafe boardwalk at Carnie Woods. They have also donated £200 of Amazon vouchers to allow us to buy a new saw.

No date yet for wash-up meeting with ACC project team

Mason Lodge – Ian Mitchell offered to ask a contractor to quote for levelling the embankment path from the Pitcairn Lodge junction to the path from Mason Lodge.

Westhill Golf Club – No change: path repairs still required, using quarry dust. Have discussed location for dust store with Manager. [Est £130]. Waymarker post to be installed.

Westhill Drive – 4 spots requiring vegetation to be cut back from public pavements. Met with Ian Mitchell 13th Sept and he agreed that LS would cut back vegetation opposite bus turning circle; Green Spaces team can cut back branches overhanging the Academy's eastern boundary fence [tba]; one of the two residents opposite the Academy has cut back their hedge; the other has still to do so.

Link north to Craigmar – no change - emails sent to Marshalls asking for meeting to discuss ideas to complete the off-road path from north edge of town to Craigmar turn-off have yet to receive a reply. Gordon will phone them.

Meadowlands Farm track & lane – n/a

Mains of Kinmundy Hill – Bench scheduled for repair in next couple of weeks.

Links east from Hillside Road –LS requested to cut back pavement vegetation from Hillside Road junction to Lawsondale turn-off.

Lawsondale – further strimming done by Community Payback team. Message of thanks sent.

Other Green Spaces

Denman Park – **PBIP Project** – progress has continued to be frustratingly slow over recent weeks. The bonded material contractor [Abacus] started on site Tuesday, 3rd September with the expectation of completing in a couple of weeks, but he too has been MIA for considerable periods. Work is due to finish this week, weather allowing. That will then allow the main contractor to do the final pieces of work.

A group of volunteers fitted new posts and rails to the repurposed bridge in the last two weeks of September so that the bridge now meets safety standards for pedestrian-only bridges. The posts and rails were donated by the contractor.

I don't intend to plan an official opening until all material laid and snags attended to.

Denman Park Flooding Issue – still a work in progress for AC officials. There are no plans to repair the damaged paths until there is confidence that the filtration unit is working effectively during periods of sustained rainfall.

Maintenance of Denman planted areas – autumn site meeting to be arranged with Ian Mitchell

Carnie Woods boardwalk removal – Total Energies two small teams managed to remove the first section of 40m on Wednesday, 25th September. TE subsequently donated £200 of Amazon vouchers to help us buy pruning saws. Rachid wrote to thank them, and I have since written to ask what lessons were learnt in relation to the remaining 200m.



Westdyke Leisure Centre accessible path – Meeting with Ian Mitchell held on 13th Sept. IM very supportive and will ask a contractor for quotation which would allow us to apply for funding.

Carnie Crescent All Weather Pitches [AWP] – AC's clerk of works would prefer an access path to be laid in tar but would accept other materials. They may be obtainable form our Denman Park contractor. Have asked Avant Homes [waste ground landowner] for consent to effect improvements.

Blackhills Court – IM is happy for the Green Spaces Team to help residents plant a screening hedge against the southern boundary fence. Considering delegating this project to ROVOP or TE, both of whom have expressed interest in "community service" projects.

Funding Update

Spent £59 on post and rail fixings for the repurposed bridge at Denman Park. Budget allocated for 2024/25 - £2,000. Spend so far - £973. Future spend may be required for quarry material at WGC, spare parts and extendable loppers. The Amazon vouchers will be used for pruning saws.

Planting Update

Town Centre bedding plants still doing well, so autumn planting of winter pansies has been postponed until the last two weeks of October. Plants will be provided from AC stock, so precise dates subject to availability and delivery.

Along with other communities in the shire, we have been invited to apply for 8 free fruit trees/bushes on a first-come-first-served basis. The trees/bushes must be planted on public land. Should we apply [by 31st October], and any thoughts on where to plant? Suggestions were the grass area at Hillside Rd/Westhill Rd junction and the park opposite the recycling centre.

Volunteers – Still 6-8 attending weekly for a couple of hours on a Wednesday morning. Sincere thanks to all.

HILL OF FARE

On 3rd October this application was discussed by the Infrastructure Services Committee and they have objected to the proposed windfarm. It will now go to a statutory public enquiry before it is determined by the Scottish Government.

PYLONS

There was a SSEN consultation at the Echt Hall on the Kintore to Tealing 400kV Overhead Line, this event was part of the pre application consultation process for the consent application to go forward this year and the plan is that the construction will be completed by 2030.

LDP

Assault – Includes all recorded instances of violence.

Housebreaking:

Public Nuisance:

There has been 6 reports.

- Youths gathering in park being loud. No unit available to attend.
- Youths on roof at the Shopping Centre and jumping in front of cars. No unit available to attend.

- Electric bike being driven on footpath. Details circulated. Rider not traced.

Road Traffic:

This period has seen 3 reported accidents.

A car struck a cyclist resulting in slight injury. The driver was issued a fixed penalty for Careless Driving.



A car and a motorcycle collided. The rider sustained minor injury and both parties exchanged insurance details.

Reports received relate to manner of driving and suspicion of alcohol and drug consumption.

Two parked vehicles were damaged in separate incidents. Enquiry is ongoing to identify the vehicles and drivers responsible.

A lorry and a car collided. No injury was sustained and insurance details were exchanged.

Drivers have been reported to the Procurator Fiscal for driving under the influence of alcohol, driving while disqualified and without insurance.

Conditional offers of fixed penalty have been issued to two drivers for Careless Driving.

Drugs:

There have been no reports. However, a male was issued a Recorded Police Warning having been found to possess Cocaine.
