A final report has been prepared with an abstract & executive summary. Agreed that this can now be sent to the Council initially. Willie suggested that any meeting with the Council should include discussion on the other bus transport issues covered in the CAP, e.g Old Skene Road residents not being near a bus stop.

## 5. Proposed 20mph Speed Limits

Becky & Gordon had commented on the proposed change. The main change we don't agree with is for Hays Way to change to 20mph. Some roads we would like to see reduced from 60mph, like Hill of Keir Rd are not marked for any change. Iris advised they will be reviewed as a separate project and asked that the Councillors be copied on the response we submit. Willie suggested we could buy a few interactive speed signs as they are not expensive and they could be moved around

Scottish Community Councils wish to do a video case study on us, mainly on the Bulletin and big projects like the Orbital Trail. David will have an initial planning call with Brian Davey on 28<sup>th</sup> April.

Kate has received a facebook request to put a memorial bench in Denman Park. Permission will be required from Landscape Services, probably Ian Mitchell. The benches that WECC have put in the park were supplied by Glasdon. They are constructed from recycled plastic so need little maintenance

## 8 Asylum Seeker Hotel (David

The monthly Community meeting was yesterday. The notes from it will be circulated when issued. Hotel numbers still around 260. Decisions are coming through but Mears are not advised if they are positive or negative.

The Green Spaces activities that Gordon has proposed the SUs could assist with have been posted on the notice board. The most popular one is rebuilding the stone wall near golf course. This should be getting done after Gordon returns from holiday.

Not sure yet if the offer of table tennis at Westdyke Leisure Centre will be taken up by the SUs

The Home Office response to our FOI request appeal was expected by 3<sup>rd</sup> April but hasn't been received yet. David will query this.

A Home Office Select Committee (HASC) meeting has been organised for Thursday 24 April in Westhill, with reps from WECC, Kingshill Church, Rotary and voluntary ESOL learning attending, to give an overview of the support they are giving and any impacts this has had. David will be attending this. Mervyn offered to also attend

## 11 Westhill Green Spaces Update

Circulated report from Gordon Prentice in italics with new points highlighted in green. Updates in normal type:-

## **Volunteer Activity Since Last Month**

**Maintenance of Denman planted areas** – our 11 consecutive weeks of pruning and trimming of the many overgrown planted areas came to an enforced end in the last week of March [owing to commencement of bird nesting season]. A total of 204 person hours were recorded; that's an average attendance of just over 9 per week, and testament to our dry winter.

## Orbital Trail Development/Maintenance [clockwise from Gateway Sculpture]

## Monthly changes highlighted in green

**Gateway Sculpture** – no activity

Hidden Garden – no activity – the paving block may need to be scraped over the coming weeks.

**Silvertrees Drive to Peregrine Road** – no activity

Mason Lodge to Pitcairn Lodge – path at junction of A944 and Pitcairn Lodge driveway – no activity Broadshade/Berryhill Circle – 20 hazel trees offered on 22<sup>nd</sup> March. No response as yet.

Westhill Golf Club – some path repairs will be required, using quarry dust – no activity

Westhill Drive – overhanging bushes opposite bus turning point – no activity

**Link north to Craigmar** – request to extend existing path by a further 100m to Craigmar junction – no activity

Meadowlands Farm track & lane – no activity

Links to Brimmond – letter received from AC's Outdoor Access team leader confirming that the owner of Northside Farm was granted planning permission for the installation of electronic gates that effectively closed the link between Westhill & Brimmond Hill. No mention was made of the barbed wire wrapped around adjacent field gate, so I have queried that.

Mains of Kinmundy Hill - no activity

**Links east from Hillside Road** – ownership of abandoned farm track and pavement vegetation from Hillside Road junction to Lawsondale turn-off – no activity

Lawsondale – spring patching work commenced Wednesday, 2<sup>nd</sup> April.

## Other Green Spaces

**Blackhills Court** – to be followed up. Have been offered a picnic table.

Carnie Woods boardwalk removal — no activity - pitched this to Mears 26<sup>th</sup> March — <mark>7 asylum seekers have signed up.</mark>



**Carnie Crescent All Weather Pitches [AWP]** – no activity - awaiting reply and consent to effect improvements to path and planted areas – to be followed up

**Denman Park – PBIP Project –** There is a small retention [circa £4k] in place to ensure that all snags are addressed. Seeding of edges and compound to be repeated in spring – no activity.

I was contacted by Susan Adams on 28<sup>th</sup> March inviting us to bid for a small amount of Developer
Obligations funding which we could use to purchase a 6-bike bike rack for Denman. The quoted cost is £900
ex VAT. Could I have the go-ahead to offer £300 [from unused PBIP project funds], or more, up to £600, if
needs be? This was approved.

"Rediscover Denman" family fun / club open day/event proposal for Saturday, 31<sup>st</sup> May accepted by the Bowling Club and Tennis Clubs. Both are keen to be involved. See Appendix 1 for proposal.

Denman/Arnhall Moss core path — no activity - improve surface of the "desire line", saving 70m between

Parkside and Tesco crossing. Green spaces Team working on widening the path tomorrow,  $9^{th}$ .

Westdyke Leisure Centre accessible path – no activity – planning to contact contractor w/c  $21^{st}$  April with a view to completion not long after.

## **ALOAF [Aberdeenshire Local Outdoor Access Forum]**

No activity – next meeting 28th April.

## **Funding Update**

Budget allocated for 2024/25 - £2,000, with £51 carried forward from 2023/4, plus £200 donated by Total Energies, totalling £2,251. Spend was £2,285 owing to an unexpected repair bill for one set of hedge trimmers, needed for the team's work in Denman Park.

## **Planting Update**

Daffodils from ACC - three bags of bulbs remain

Summer Bedding Plants – to be funded from WECC budget

**Cherry Tree Avenues** - Tajana Sosic has applied to the Nature Restoration Fund on our behalf to fund native trees and wild flowers on Jubilee Drive and Westhill Drive [Denman Park] to brighten up the entrance to Westhill from the east. The farmer who owns the field to the north of Jubilee Drive has informed us that he does not want trees to be planted on his verge.

**Funding Update** – The budget of £1,000 was overspent by £173 owing to approval being given to purchase a batch of 25 mature azalea plants for Denman Park. Unfortunately, the new young plants have proven to be a tasty snack for our wild deer population!

**Shopping Centre Planters**- Mervyn is in discussion with David Waterworth of LCP about arrangements for watering the half-barrel planters at front of shops. We can supply the summer bedding plants for them and will paint the barrels

### **Litter Picks**

A record equalling 21 attended our rescheduled pick on 29<sup>th</sup> March, following the postponement on the 22<sup>nd</sup>. Next pick is this Saturday 12<sup>th</sup> April



Additional Bins in Westhill — we received an email from Head of Waste Collections suggesting a meeting once her team had completed its audit of bin locations. Budget restrictions will mean that we shouldn't expect new bins, but some may be repositioned to meet demand.

**Restoration of bin in Aldi car park** – no action - to be followed up.

Gordon & David had a call yesterday with Paula Houston of ESCC who is keen to address the issue of roadside takeaway litter between Garlogie & Echt. We will jointly approach the Council Waste Team and Keep Scotland Beautiful about how best to proactively tackle fast-food waste

## "Rediscover Denman"

Aims – to provide an informative and enjoyable community event to promote awareness of Denman Park facilities and conduct the Official Opening of the new circular paths and bridges.

### **Promoters/Organisers – WECC**

**Context** – Over the last 2 years, and after a considerable investment of time and effort by the WECC Greenspaces Team with support from Aberdeenshire Council, major investment was secured to design, and lay 900m of new internal paths around Denman Park; replace one of the two existing bridges, and to provide two additional bridging points to make the features of the park more accessible for all abilities. Simultaneously, Rotary Westhill also secured funding to install a new pétanque court near the pavilion. Time and effort has also been spent cutting back and restoring most of the shrubbery and verges that suffered from neglect due to Covid shutdown and recent budget cuts.

All this work has been designed to make the park a more accessible and pleasant place to spend time in, and very importantly, to help facilitate healthy lifestyles. The emphasis on healthy living, accessibility and much improved connectivity was of central importance in securing funds from the Scottish Government's Place Based Investment Programme.

**Results so far** – All the major work has been completed to a high standard and the new and existing paths have, where possible been designed or upgraded to allow use by wheelers; with wheelchair and pushchair users particularly in mind. There is now clear evidence that footfall in the park has increased significantly without any formal promotion of improvements made other than updates on social media.

**Vision** - WECC believes that the value of Denman Park to the wider community can be significantly increased by spreading the word about park facilities via "Rediscover Denman", particularly to those who live on the west side of the town and those who work in Arnhall Business and Retail Parks. Publicity via Bulletin approximately 1 week before hand. Also via social media and press release. Action: draft press release and distribution list

## 12 COMMUNITY ACTION PLAN (Diane Priestly)

Circulated report in italics:-

**Green spaces audit**- the planning group spent the morning pulling together the data gathered from the volunteers who have logged the various green spaces in Westhill and Elrick and the various play parks, overgrown hedges, potholes, the state of the paths, trees and health and safety issues. The next stage of this exercise is to visit Denman Park (29<sup>th</sup> April) to see if it is possible to establish a children's playpark there.

**Local Place Plans**-we are looking for more information about what will be required by WECC if we go ahead with this. The LDP newsletter shows several examples of local place plans that have already been completed and when you look at these plans you will see that they are extremely detailed and aligned to the National Planning Framework 4. What are your thoughts on WECC undertaking this task?

Audrey will be attending the Community Planning meeting next week re Place Plans and will find out if we can feed a lot of our CAP data into a Place Plan.

## **PLANNING APPLICATIONS**

APP/2024/1762 Costco is planning to add a petrol station to the Westhill site, plus installation of ev charging points, landscaping and associated works-awaiting a decision-holding response from the infrastructure services and roads-awaiting decision,

APP /2024/2150 McDonalds Restaurant Venture Way Arnhall Business Park Westhill Ab326BQ Full Planning Permission for the installation of 2 ev charging stations with ancillary substation and infrastructure refused. APP/2025/0157 Alatas enterprise house Enterprise Drive AB326TQ full planning permission for the erection of a boundary fence-awaiting decision

APP/2025/0428 Chap Construction Enterprise Drive AB326TQ full planning permission for siting of Cabin and Alterations to Workshop

ENQ/2025/0215 Land at Mosscroft Avenue, AB326TQ-Proposal of Application Notice for the Erection of Residential Units, 50-60units with Associated Open Space Roads and Infrastructure



Several of us went along to view the proposed development for 50 -60 affordable house /flats on the former Stewart Milne building and we were informed that a further 49 affordable homes are planned for Peregrine House. There will be a second engagement event on the 20<sup>th</sup> August at the Westhill Community Church between 3.30pm & 7.30pm. These properties will be in addition to the affordable houses /flats still not completed opposite the Hampton Hotel. We will advertise the 20<sup>th</sup> August event in Summer Bulletin.

There are plans by Westhill Park Homes to develop 24 quality homes in what was the mobile site opposite Tritech International Limited which is off the Straik Road. These homes will be suitable for the over fifties' singletons, families and retired people. Prices range from £185,000 to £255,000. The original planning application for 30 residential caravans was made in 1975 which implies 50 years ago.

Diane will go back to planners to query how a 50 year-old planning application can still be valid and point out to them that Park Homes are not caravans. Surely this should be treated as a Change of Use.

#### HILL OF FARE

This application is now moving forward and the next process is that it will now be subject to a Public Local Enquiry. If you want to be part of this enquiry you need to contact <a href="mailto:Hazel.Bailey@gov.scot">Hazel.Bailey@gov.scot</a> from the DPEA.

### **PYLONS**

Continuing concerns over the installation of high pylons and the need for better consultations by SSEN as they not listening to the locals.

#### KINTORE HYDROGEN PRODUCTION PLANT

The proposed application to build a hydrogen production plant near Kintore which would be one of the largest sites in Europe was recommended for refusal by councillors however the final decision will be made this month at the next full council meeting.

## **ENERGY CONSENTS UNIT**

In the last 28 days 10 applications have been approved this includes 2 windfarms, 2 Battery Energy Storage Systems, 1 energy solar park, 4 overhead power lines and a hydro renewable project.
